Successful placement of a €750 million bond for Unibail-Rodamco

Unibail-Rodamco SE announces that it has successfully placed an 8-year bond maturing February 2021 for a total amount of €750 million.

The bond will offer a fixed coupon of 2.375%. The placement was 2.5 times oversubscribed, the order book reaching over €1.9 billion.

This placement confirms the confidence of bond investors in Unibail-Rodamco's credit profile.

The net proceeds from the bond will strengthen the liquidity of the Group.

Unibail-Rodamco is rated A (stable outlook) by Standard & Poor's and FitchRatings.
