

**" EMERGENCY CIRCULAR "**

1. To prevent spread of MONKEYPOX Disease into Bangladesh through sea route, all ships arriving to Chittagong Port shall exercise following precautionary measures;
  - a. Vessel calling Chittagong Port will submit declaration of infected/suspected MONKEYPOX crew (s) onboard and report to Port Control prior dropping anchor.
  - b. No officer/Crew shall be granted shore pass without prior approval of Port Health Officer (PHO).
  - c. Signed off Crew shall remain under health check up by PHO prior out pass from immigration gate (Gate No. 1) of Chittagong Port.
  - d. Any information regarding MONKEYPOX symptomatic patient on boardship shall be informed to Port Control Room (Tel No: 02333326916, VHF Channel-12) and to Port Health Officer immediately. In such case ship's movement/cargo operation will be subjected to PHO inspection report.
