



Buy Any Crypto Asset for the First Time and Get \$5 in Bitcoin

As part of the TBC Crypto campaign (hereinafter the “Campaign”), starting from 24 June 2026, 15:00, the first 1,000 customers who purchase any crypto asset for the first time in TBC Mobile Bank will receive \$5 worth of Bitcoin as a gift.

Detailed Terms and Conditions of the Campaign (hereinafter the “Terms”)

- The Campaign starts on **24 June 2026 at 15:00**.
- For the purposes of this Campaign, a customer is considered eligible if they had not executed a crypto asset purchase order in TBC Mobile Bank before **24 June 2026, 15:00**, and executes a crypto asset purchase order for the first time starting from **24 June 2026, 15:00**.
- Only the customer’s first successfully completed crypto asset purchase order executed from **24 June 2026, 15:00** onwards will participate in the Campaign.
- Only successfully completed crypto asset purchase orders are eligible for participation in the Campaign.
- Under the Campaign, the first **1,000 (one thousand)** customers who meet the Campaign conditions will receive the gift.
- Each customer may receive the gift only once within the framework of the Campaign.
- The customer’s second and each subsequent purchase order will not participate in the Campaign.
- The gift consists of Bitcoin equivalent to **\$5 (five US dollars)** (hereinafter the “Gift”).
- The amount of Bitcoin to be credited will be determined based on the market rate available in the Crypto Module of TBC Mobile Bank at the moment the Gift is credited to the customer’s crypto account.
- The Gift will be credited to the customer’s crypto account no later than **1 business day** after the execution of the purchase order, and the customer will receive a confirmation SMS regarding the crediting.
- The Campaign applies only to users of the Crypto Module in TBC Mobile Bank who are **18 years of age or older**.
- To participate in the Campaign and receive the Gift, the customer must maintain an active crypto account until the Gift is credited.
- The Bank is authorized to verify whether the purchase order complies with the Campaign Terms.
- In the event of suspicious, unlawful, or fraudulent activity, the Bank is entitled to exclude the customer from the Campaign and withhold the Gift.
- The Bank is not responsible for a customer’s failure to receive notifications due to incorrect or inactive contact information registered with the Bank.
- The Bank is not responsible for the inability to participate in the Campaign caused by technical disruptions and/or circumstances beyond the Bank’s control.
- The Campaign will automatically end once the limit of the first **1,000 (one thousand)** customers has been reached.



- The customer acknowledges and confirms that the Campaign does not constitute investment, legal, or any other type of financial advice provided by the Bank. The Bank assumes no responsibility for future financial results.
- The Bank shall not be liable for any direct, indirect, special, incidental, or consequential damages resulting from the unlawful use of the Campaign or the Gift received within the Campaign and/or from a violation of these Terms.
